Atypical Maternal Behavior Instrument for Assessment and Classification (AMBIANCE)

The Atypical Maternal Behavior Instrument for Assessment and Classification (AMBIANCE) was developed in our lab from 1991-1999 to fill a need in the field for a coding instrument for the atypical maternal behaviors seen among high-risk and clinical cohorts. Training workshops are held on request from other researchers for training to reliability in use of the coding system. The coding system is now in use in labs internationally (see other professional activities for listing).

Rating for Infant Stranger Engagement (RISE).

The RISE was also developed and validated in our lab in 2004-2008 as the first observationally-based assessment of the indiscriminate attachment behaviors that constitute the criterion for the diagnosis of Reactive Attachment Disorder: Disinhibited Type. In 2009 we will train the first external lab in the use of this measure (Lab of Dr. Isabel Soares, University of Minho, Braga, Portugal).

Narrative Report

I am a developmental researcher and clinical psychologist. My major academic role at the medical school is as a developmental psychopathology researcher. As I began my research career, the prevailing understanding was that we could not identify in infancy those who would

develop psychopathology later in childhood or adulthood. Given the potential importance of such early identification, I began a prospective longitudinal study of children from adverse environments in infancy. The study has examined whether predictors of child and adult psychopathology can be identified during the first years of life. I also teach developmental theory and research to the HMS child psychiatry fellows, and disseminate new research in developmental psychopathology to practicing clinicians through national and international clinical speaking and writing. Approximately two-thirds of my time has been devoted to research, with one-third devoted to teaching, supervision, and clinical activities.

The initial focus of our longitudinal study was on the long-term risks potentially associated with maternal depression and disorganized parent-infant attachment relationships. Publications from the study were among the first to demonstrate the deleterious effects of maternal depression on infant development, in a series of publications from 1986 to 1993. . These reports, in concert with those from other labs, produced an explosion of interest in the influence of maternal depression on infant development that continues to the present. In addition, our early publications documented for the first time the increased risk for psychopathology associated with disorganization of the attachment relationship in infancy. These findings, along with associated findings from other labs, led NIMH to convene an expert panel in 1992, for which I was a contributing member, on Attachment and Psychopathology, aimed at examining the implications of this body of work for research priorities at NIMH. Subsequently, our lab has developed and validated an assessment tool for atypical forms of maternal behavior associated with disorganization of the infant's attachment behavior (AMBIANCE assessment). We have subsequently found that these early maternal behaviors make unique contributions to the prediction of psychopathology in childhood and young adulthood. The AMBIANCE assessment is now used both nationally and internationally. More recently, we are collaborating with neuroscience and genetics colleagues to examine the influence of early maltreatment and genetic vulnerability on later brain function.

My teaching activities include mentoring graduate students and post-doctoral fellows in my lab and training other laboratories in the use of the AMBIANCE assessment. I have also been teaching the fall semester of the required Processes of Normal Development course for the 18 first - year Child Psychiatry Fellows from Mass. General/McLean, Children's Hospital, and Cambridge Hospital. In 2005, I received a teaching award from the MGH/McLean Child Psychiatry Division for this course.

In summary, my teaching, research and clinical contributions have been oriented to bringing new developmental research to bear on understanding the emergence of clinical disorder. This work has contributed to the growing recognition that many child and adult psychiatric conditions have developmental precursors that are evident long before a disorder can be diagnosed.
